1. This invitation for pre-qualification follows the General Procurement Notice for this project that appeared in the PPRA's Tender Portal and RAHCO's website on 9th September, 2017.
2. The Government of Tanzania through Reli Assets Holding Company (RAHCO) has set aside funds for the operation of the Reli Assets Holding Company Limited (RAHCO) during the financial year 2017/2018. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the Supply, Testing, Commissioning and Training of Rolling Stock for Standard Gauge Railway (SGR) Railway System to Operate in Tanzania Central Railway Corridor
3. Pre-qualification will be conducted through International Competitive Tendering Procedures set out in the Public Procurement Act No.7 of 2011 and its Public Procurement (Amendment) Act No. 5 of 2016, Public Procurement Regulation, 2013 and its Public Procurement (Amendment) Regulation, 2016, and is open to all Applicants as defined in the Regulations.
4. Characteristics of the SGR Line: will be of 60Kg/m rails fixed on Mon block Concreted sleepers electrified having operating speeds of 160 Kmph for Passengers Trains and 120Kmph freight trains. The line has capacity to handle 2,000m long trains having axle load of 35 Tones per axle with design radius of 1,900m and maximum grade of 1.6%. Will be installed with ETCS Level-2 with GSMR.
