- 3. Minimum Average Turn Over of Bidder (in crore Rs.) of last three financial years in specific to the Service : 0.65

- 5. Average Annual financial turnover of related services during the last three years, ending 31st March of the previous financial year, should be at least 30% (Thirty per cent) of the estimated cost. (Seller to upload relevant document as part of bid submission. Buyer will verify the documents submitted by seller.)
- 6. The bidder must have at least three years experience (ending month of March prior to the bid opening) of providing similar type of services to Central/State Government/PSUs/Nationalised Banks/Reputed Organisations. Services rendered with list of such Central/State/PSUs/Nationalised Banks/Reputed Organisations with duration of service shall be furnished. - 7. The bidder must have successfully executed/completed similar services, over the last three years i.e. the current financial year and the last three financial years:- (Seller to upload relevant document as part of bid submission. Buyer will verify the documents submitted by seller.)
 - 1) Three similar completed services costing not less than the amount equal to 40% (Forty per cent) of the estimated cost; or
 - 2) Two similar completed services costing not less than the amount equal to 50% (Fifty per cent) of the estimated cost; or
 - 3) One similar completed service costing not less than the amount equal to 80% (Eighty per cent) of the estimated cost.
