- 3. The Purchaser reserves the right to increase or decrease the ordered quantity up to 25 percent at the time of placement of contract . The purchaser also reserves the right to increase the contracted qty up to 25% during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly
- 4. The bidder must have successfully executed/completed similar services, over the last three years i.e. the current financial year and the last three financial years:- (Seller to upload relevant document as part of bid submission. Buyer will verify the documents submitted by seller.)
 - 1) Three similar completed services costing not less than the amount equal to 40% (Forty per cent) of the estimated cost; or
 - 2) Two similar completed services costing not less than the amount equal to 50% (Fifty per cent) of the estimated cost; or
 - 3) One similar completed service costing not less than the amount equal to 80% (Eighty per cent) of the estimated cost.

This RA is governed by the <u>General Terms and Conditions</u>, conditions stipulated in RA and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
